GENERAL INFORMATION

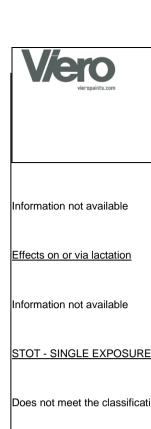
